

# Davis New York Venture Fund

A History of Outperformance. Positioned for the Future.



## Historically, the longer investors stayed with us, the more likely they earned attractive returns.

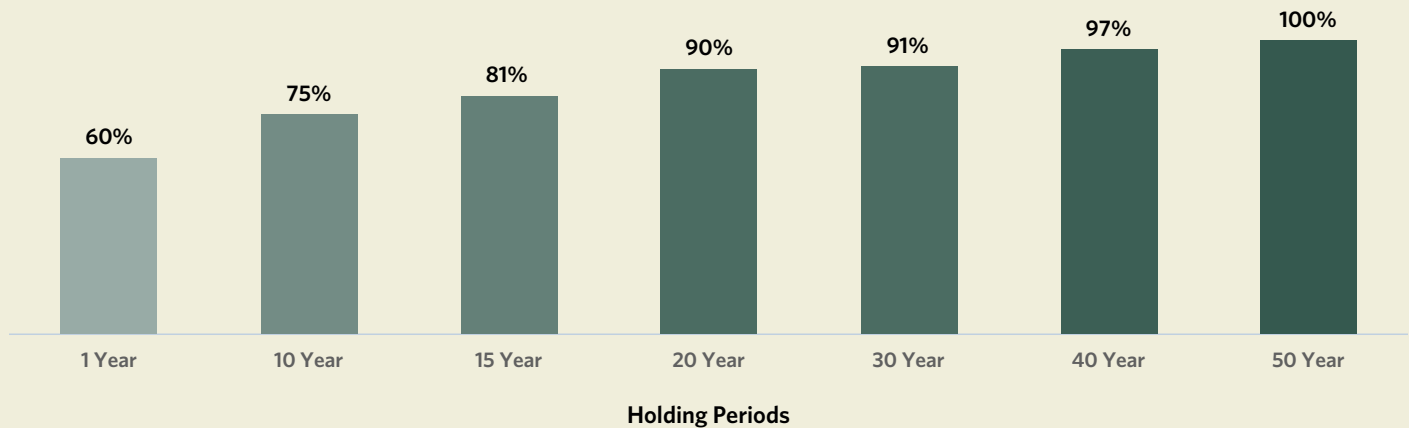
Davis New York Venture Fund outperformed the market with a great degree of consistency over the long-term. As shown below, the Fund outperformed the market in 75% of all ten year periods since its inception. As an investor's holding period increased, the likelihood of outperforming also increased, ultimately reaching 100% of periods.

The result: \$10,000 grew to \$3,310,161 vs. \$2,086,863 for the S&P 500 Index since inception.

## Today, we believe the Fund is well-positioned for the future by owning a selective portfolio of businesses growing at a similar rate to the index, yet selling at a discount:

**Objective and Risks.** The investment objective of Davis New York Venture Fund is long-term growth of capital. There can be no assurance that the Fund will achieve its objective. **Outperforming the Market.** Davis New York Venture Fund's average annual total returns for Class A shares were compared against the returns of the S&P 500 Index as of the end of each quarter for all time periods shown from 2/17/69, through 6/30/23. The Fund's returns assume an investment in Class A shares on the first day of each period with all dividends and capital gain distributions reinvested for the time period.
