Not all assets of the Funds and Portfolios are accounted for in the calculation of 5-year EPS as relevant information on certain companies is not available to the Advisor's data provider. Approximate amounts are: DNYVF: 6.14%; DIF: 22.83%; DGF: 17.99%; DFF: 10.75%; DOF: 14.30%. The 5-year EPS of the S&P 500 is 18.5%. The 5-year EPS of the MSCI ACWI ex US is 13.1%. The 5-year EPS of the S&P 500 Financials is 13.4%. The 5-year EPS of the S&P 1500 is 18.3%.

2. Forward Price/Earnings (Forward P/E) Ratio is a stock's current price divided by the company's forecasted earnings for the following 12 months. The values for the portfolio are the weighted average of the P/E ratios of the stocks in the portfolio. The Forward P/E of the S&P 500 is 26.2%. The Forward P/E of the MSCI ACWI ex US is 17.0%. The Forward P/E of the MSCI ACWI is 22.1%. The Forward P/E of the S&P 500 Financials is 18.3%. The Forward P/E of the S&P 1500 is 25.6%.

Objective and Risks. The investment objective of Davis New York Venture Fund, Davis Global Fund, Davis International Fund, Davis Opportunity Fund, and Davis Financial Fund is long-term growth of capital.
