Objective and Risks. Davis Equity Portfolio's investment objective is long-term growth of capital. There can be no assurance that the Portfolio will achieve its objective. Some important risks of an investment in the Portfolio

are: stock market risk: stock markets have periods of rising prices and periods of falling prices, including sharp declines; **common stock risk**: an adverse event may have a negative impact on a company and could result in a decline in the price of its common stock; financial services risk: investing a significant portion of assets in the financial services sector may cause the Fund to be more sensitive to problems affecting financial companies; foreign country risk: foreign companies may be subject to greater risk as foreign economies may not be as strong or diversified. As of 3/31/25, the Fund had approximately 17.8% of net assets invested in foreign companies; China risk - generally: investment in Chinese securities may subject the Fund to risks that are specific to China including, but not limited to, general development, level of government involvement, wealth distribution, and structure; headline risk: the Fund may invest in a company when the company becomes the center of controversy.
