Objective and Risks. The investment objective of Davis Financial Portfolio is long-term growth of capital. There can be no assurance that the Fund will achieve its objective. Some important risks of an investment in the Fund are: **stock market risk:** stock markets have periods of rising prices and periods of falling prices, including sharp declines; **manager risk:** poor security selection may cause the Fund to underperform

relevant benchmarks; **common stock risk:** an adverse event may have a negative impact on a company and could result in a decline in the price of its common stock; **large-capitalization companies risk:** companies with \$10 billion or more in market capitalization generally experience slower rates of growth in earnings per share than do mid- and small-capitalization companies; **mid- and small-capitalization companies risk:** companies with less than \$10 billion in market capitalization typically have more limited product lines, markets and financial resources than larger companies, and may trade less frequently and in more limited volume; **headline risk:** the Fund may invest in a company when the company becomes the center of controversy. The company's stock may never recover or may become worthless; **financial services risk:** investing a significant portion of assets in the financial services sector may cause the Fund to be more sensitive to problems affecting financial companies; **foreign country risk:** foreign companies may be subject to greater risk as foreign economies may not be as strong or diversified. As of 3/31/26, the Fund had approximately 20.8% of net assets invested in foreign companies; **emerging market risk:** securities of issuers in emerging and developing markets may present risks not found in more mature markets; **foreign currency risk:** the change in value of a foreign currency against the U.S. dollar will result in a change in the U.S. dollar value of securities denominated in that foreign currency; **depository receipts risk:** depository receipts involve higher expenses and may trade at a discount (or premium) to the underlying security; **focused portfolio risk:** investing in a limited number of companies causes changes in the value of a single security to have a more significant effect on the value of

the Fund's total portfolio; **interest rate sensitivity risk:** interest rates may have a powerful influence on the earnings of financial institutions; **credit risk:** The issuer of a fixed income security (potentially even the U.S. Government) may be unable to make timely payments of interest and principal; and **fees and expenses risk:** the Fund may not earn enough through income and capital appreciation to offset the operating expenses of the Fund.
